- Low attendance in: Hampton (8), Virginia Beach (9)

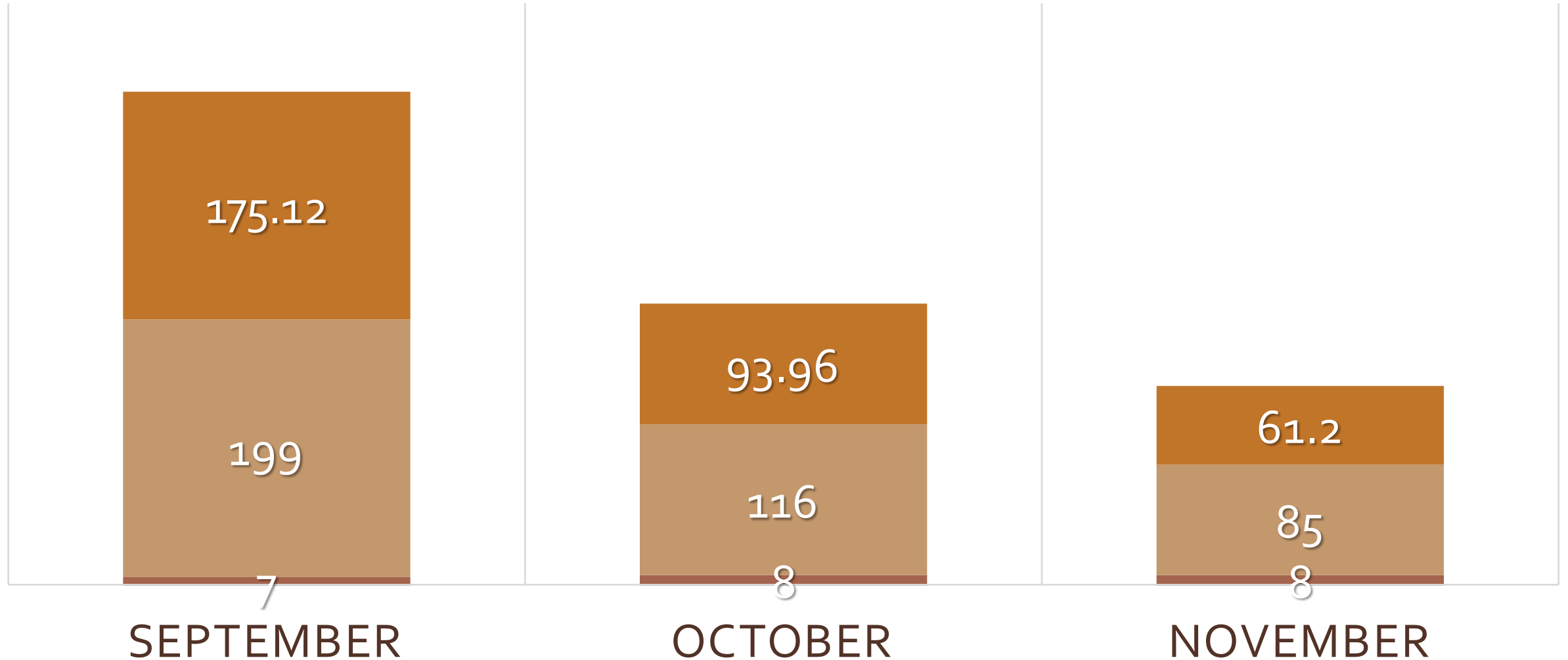
## NOVEMBER:
